1. It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise raids on hostel and other place vulnerable to incidents and having the potential for ragging and shall be empowers to inspect such places.
2. It shall also the duty of the Anti-Ragging Squad to conduct an on the spot enquiry into any incidents of ragging referred to it by the Head of the Institution or any member of the faculty/staff/student/parent/guardian/ any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the Anti-Ragging Committee for action. Provided the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student accused of ragging and other witnesses to place before it the facts, documents and views concerning the incidents of ragging and consideration such other relevant information as may be required.
3. Anti-Ragging Squad will function till further order.


